## **Vision Statement:**

Under the Equality Act 2010 schools should have an Accessibility Plan. The Equality Act 2010 replaced all existing equality legislation, including the Disability Discrimination Act. The effect of the law is the same as in the past, meaning that "schools cannot unlawfully discriminate against students because of sex, race, disability, religion or belief and sexual orientation". According to the Equality Act 2010 a person has a disability if:

He or she has a physical or mental impairment, and

- (a) The impairment has a substantial and long-term adverse effect on his or her ability to
- (b) carry out normal day-to-day activities.

The Accessibility Plan is listed as a statutory document of the Department for Education's guidance on statutory policies for schools. The Plan must be reviewed every three years and approved by the Governing Body. The review process can be delegated to a committee of the Governing Body, an individual or the Head.

At Chorley New Road Primary Academy the Plan will form part of the School Improvement Plan and will be monitored by the Head and Estates Manager and each target evaluated by the relevant Governors' committee. The current Plan will be appended to this document following its publication.

At Chorley New Road Primary Academy we are committed to working together to provide an inspirational and exciting learning environment where all children can develop an enthusiasm for lifelong learning. We believe that children should feel happy, safe and valued so that they gain a respectful, caring attitude towards each other and the environment both locally and globally.

- 1) The Chorley New Road Primary Academy Accessibility Plan has been developed and drawn up based upon information supplied by the Local Authority, and consultations with students, parents, staff and governors of the school. The document will be used to advise other school planning documents and policies and will be reported upon annually in respect of progress and outcomes. The intention is to provide a projected plan for a three year period ahead of the next review date.
- 2) The Accessibility Plan is structured to complement and support the school's Equality Objectives, and will similarly be published on the school website. We understand that the Local Authority may monitor the school's activity under the Equality Act 2010 (and in particular Schedule 10 regarding Accessibility) and will advise upon the compliance with that duty.
- 3) Chorley New Road Primary Academy is committed to providing an environment that enables full curriculum access that values and includes all students, staff, parents and visitors regardless of their education, physical, sensory, social, spiritual, emotional and cultural needs. We are committed to taking positive action in the spirit of the Equality Act 2010 with regard to disability and to developing a culture of inclusion, support and awareness within the school.

- 4) The Chorley New Road Primary Academy Accessibility Plan shows how access is to be improved for disabled students, staff and visitors to the school within a given time frame and anticipating the need to make reasonable adjustments to accommodate their needs where practicable. The Accessibility Plan contains relevant and timely actions to:-
  - Increase access to the curriculum for students with a disability, expanding the **curriculum** as necessary to ensure that students with a disability are as, equally, prepared for life as are the able-bodied students; (If a school fails to do this they are in breach of their duties under the Equalities Act 2010); this covers teaching and learning and the wider curriculum of the school such as participation in after-school clubs, leisure and cultural activities or schools visits it also covers the provision of specialist or **auxiliary aids and equipment**, which may assist these students in accessing the curriculum within a reasonable timeframe;
  - Improve and maintain access to the **physical environment** of the academy, adding specialist facilities as necessary this covers improvements to the physical environment of the school and physical aids to access education within a reasonable timeframe;
  - Improve the delivery of **written information** to students, staff, parents and visitors with disabilities; examples might include hand-outs, timetables, textbooks and information about the school and school events; the information should be made available in various preferred formats within a reasonable timeframe.
- 5) The Chorley New Road Primary Academy Accessibility Plan relates to the key aspects of physical environment, curriculum and written information.
- 6) Whole school training will recognize the need to continue raising awareness for staff and governors on equality issues with reference to the Equality Act 2010
- 7) This Accessibility Plan should be read in conjunction with the following

- 8) The Accessibility Plan for physical accessibility relates to the Access Audit of the School, which remains the responsibility of the governing body. It may not be feasible to undertake all of the

works during the life of this accessibility plan and therefore some items will roll forward into subsequent plans. An accessibility audit will be completed by the school prior to the end of each period covering this plan in order to inform the development of a new Accessibility Plan for the ongoing period.

- 9) Equality Impact Assessments will be undertaken as and when school policies are reviewed. The terms of reference for all governors' committees will include the need to consider Equality and Diversity issues as required by the Equality Act 2010.
- 10) The Accessibility Plan will be published on the school website.
- 11) The Accessibility Plan will be monitored through the LGC.
- 12) The Accessibility Plan may be monitored by Ofsted during inspection processes in relation to Schedule 10 of the Equality Act 2010.

## 2. Aims and Objectives

### Our Aims are:

- o Maintaine access to the curriculum for students with a disability
- o Improve and maintain access to the physical environment
- o Improve the delivery of written information to students

Our objectives are detailed in the Action Plan below

## 3. Current good practice

We aim to ask about any disability or health condition in early communications with new parents. For parents of children already at the school, we collect information on disability as part of a survey of parents' views, or in conjunction with a letter home about a parents' evening.

#### **Physical Environment**

Disabled students participate in extra-curricular activities. Some aspects of extra-curricular activities may present particular challenges, for example: lunch and break times for students with social/interaction impairments, after-school clubs for students with physical impairments, school trips for students with medical needs. Our school has lifts to provide access to all areas. If necessary we will relocate activities so that all children can participate.

#### Curriculum

There are areas of the curriculum to which disabled students may have limited access. Some areas of the curriculum present particular challenges, for example: PE for students with a physical impairment, science and technology for students with a visual impairment. Other issues may affect the participation of disabled students, for example: peer relationships, policies on the administration of medicines, the provision of personal care, the presence or lack of role models or images of disabled people, in effect, all the school's policies and procedures, written and unwritten. We will address needs on an individual basis to support children in accessing the full curriculum.

### **Information**

Different forms of communication are made available to enable all disabled students to express their views and to hear the views of others. Access to information is planned, with a range of different formats available for disabled students, parents and staff.

#### 4. Action Plan

The Action plan will show:

- Clear allocation of lead responsibility;
  - Clear allocation of resources;
  - An indication of expected outcomes or performance criteria;
  - Clear timescales; and
  - A specified date and process for review.

## 5. Access Audit

The school is a recently new build, consisting of Ground and First Floor. The school has several entry points, the main entrance features a secure lobby and has been fitted with a push button electrically operated external sliding doors. Two double doors located at each end of the building, each classroom on the ground floor has a door leading out to the rear playground, and further double door also leads out to the rear playground. There is also a double door leading to the front of the building from the kitchen and a double louvre door leading from the boiler house to the front of the school. There is a stepped area outside the front main entrance to building. A passenger lift located just passed the reception area access via double doors. The lift can accommodate a large wheelchair which is maintained on a regular basis through Pickerings lifts. There is a Staircase located at each end of the school, leading to the first floor level, Evacuation chairs (EVAC) are located at the top of each stair way, staff are trained to transfer disabled children from their wheel chair to the EVAC chair and take them safely from the building in the event of a fire.

On-site car parking for staff includes a dedicated disabled parking bay which is available for visitors. A low reception hatch, being fully accessible to wheelchair users. There are disabled toilet facilities available in the EYFS

area..

The school has internal emergency signage and escape routes are clearly marked, this includes signage which indicates which escape routes are appropriate for wheelchair users.

## 6. Management, coordination and implementation

Our key objective is to reduce and eliminate barriers to access to the curriculum and to ensure full participation in the school community for students, and prospective students, with a disability.
